#### **Our Vision**

The Rotary Club of Orillia (the "Club") is an organization of business, professional, and community leaders who come together through commitment and fellowship to create opportunities and a better future for generations who follow.

#### **Our Mission**

It is our mission to embrace the ideals of Rotary International, contributing to a better community and a better world through significant service while providing extraordinary opportunities for networking, fellowship, friendship and personal growth.

#### **Rotary Basics**

Rotary International, the world's first service Club organization, is made up of over 33,300 Clubs in more than 208 countries and geographical areas. Its members form a global network of business and professional leaders who volunteer their time and talents to serve their communities and the world.

**Rotary's motto**, 'Service above Self', exemplifies the humanitarian spirit of the organization's more than 1.2 million members. Strong fellowship among Rotarians and meaningful community and international service projects characterize Rotary worldwide.

#### Fellowship

Beyond Community service, Rotary activities include fellowship, social activities and the opportunity to form strong, lifelong friendships. We combine service projects with fellowship activities afterwards. There are pot luck dinners, pig roasts and cocktail events.

#### The Organization of Rotary

Rotary is essentially a grassroots organization, with most of its service efforts being carried out at the Club level. The district and international structure is designed to support the Clubs and help them provide more service in their communities and abroad.

- **Clubs**: Rotarians are members of Rotary Clubs, which belong to the global association Rotary International (RI). Each Club elects its own officers and enjoys considerable autonomy within the framework of Rotary's constitution and bylaws.
- **Districts**: Clubs are grouped into 530 RI districts, each led by a District Governor, who is an officer of RI. The District administration, composed of Assistant Governors, Directors and committees, guides and supports the Clubs.

- **RIBoard**: The RI Board of Directors, which includes the RI President and President-elect, meets quarterly to establish policies. Traditionally, the RI President, who is elected annually, develops a theme and emphasis for the year.
- **The Secretariat**: Rotary International is headquartered in the Chicago suburb of Evanston, Illinois, USA, with seven international offices.

#### How it works

While both staff members are welcome and encouraged to attend meetings, the flexibility to 'share' attendance helps your business/organization to maintain a regular presence at functions, dinners and official events. This has been specifically tailored for busy individuals, finding it difficult to commit to a regular weekly attendance.

We suggest your Primary member should be from your Executive, with Designate members then appointed by the Primary member. This enables you to develop your own specialized strategy for participation in Club activities.

#### **Key Membership Criteria**


- Your business/organization can have one Primary and one Designate member;
- The Primary member and Designate member will follow the Club's standard new member approval process;
- Your business/organization is able to replace a member when necessary. All new members will follow the Club's standard new member approval process; and
- The annual Business membership fee for the primary member and the Designate member will be set by the Rotary Club.

#### **Responsibilities of Club Membership**

The Club is the cornerstone of Rotary, where the most meaningful work is carried out. Effective Rotary Clubs work together on these four key elements:

- 1. Sustaining or increasing their membership base;
- 2. Participating in service projects that benefit their community and those in other communities;
- 3. Supporting The Rotary Foundation financially and through program participation; and
- 4. Developing leaders capable of serving in Rotary beyond the Club level.

What Rotarians get out of Rotary depends largely on that they put into it. Many of the membership activities are designed to help members engage in their club and fully appreciate their Rotary experience.
